Phone Script for Calling Landlords

Phone Call-

Hi, I was calling about your unit for rent at Is it still available?
➤ If the unit is not available, ask them if they have any others that are / would be available soon. And just to confirm the rent you had listed online is?
And what utilities would I be responsible for?
What is the total cost of moving in? Such as, application fee, security deposit, move in fees, move out fees, pet deposits (if applicable)
If the unit is available and you are interested in setting up a showing
With Housing Voucher: "I have a housing voucher with Housing Authority." Follow with telling them about yourself and be honest

Some Examples of how to talk about yourself and being honest

- Do you have a job? Do you have income?
- Community supports
- Do you keep your spaces clean?
- Past evictions?
- Rental history
- Prior or current convictions? If from long ago...mention that
- Credit score/what you're doing to improve your credit score


It is important to be honest with the Landlord from the beginning. The Landlord will find out most of this information from the application process but being upfront may work towards your advantage.

<u>Don't forget to mention your **strengths**!</u> Think about what a landlord would want to hear from a potential tenant.

If they're open to setting up a showing.... Get a few times that work for them and you. If they're NOT, that's okay too. Thank them for their time and hang up.

Housing:

- Subsidized housing (public housing, Section 8 and other rental assistance) evictions, termination of assistance, rent calculations, and admissions issues
- Discrimination and disability accommodation
- Eviction from mobile home parks
- Evictions by private landlords
- Housing protection for seniors, veterans, people living with HIV/AIDS

Overview of Landlord and Tenant Rights and Responsibilities

Tenant Rights

- Request lease in writing
- Access the premises unless a legal eviction is enforced (no illegal lockouts)
- Get their security deposit back
- End a lease/rental agreement because of domestic violence or the threat of domestic violence under the Illinois Safe Homes Act
- Equal treatment by their current or prospective landlord, regardless of race, color, religion, sex, national origin, ancestry, age, order of protection status, marital status, physical or mental disability, military status, sexual orientation, pregnancy, or unfavorable discharge from military service in connection with financial transaction, access to financial credit, the availability of public accommodations, and immigration status

Tenant Responsibilities

- Pay rent on time
- Keep the rental clean and undamaged
- Dispose of trash in designated areas
- Pay for damages beyond normal wear and tear
- Pay the utility bill if the lease says so
- Seek approval from landlord to make changes to the rental unit
- Comply with the lease

Landlord Rights

- Set the amount of rent and security deposit
 - If there is only an oral lease, the landlord has the right to change the rent monthto-month
 - If there is a written lease, then the rent the tenant owes is as specified in the lease
- Charge tenants a reasonable fee for late payments
- Make reasonable rules and regulation

Landlord Responsibilities

- Keep rentals fit to live in
- Make all necessary repairs
- Keep the rental in compliance with state and local codes

Landlords cannot:

- Enter tenants' units without their permission
- Evict tenants without good cause:



Reasonable Cause for an Eviction:

- Nonpayment of rent
- Lease violation
- Severe damage to the building
- Illegal activities






Hoarding Safety Tips







Hoarding – safety tips

If you store large amounts of possessions in and around your home, you can help keep yourself safe from fire by following the advice overleaf. Our 'top tips' are small, simple steps that can easily be included in your regular weekly/daily clearance sessions.





Helping hoarders reduce the risk of fire – top tips

- Whether you use a traditional oven/ hob, or other methods of cooking like a portable stove, make it a priority to keep the cooking area clear.
- Do not place items on, or close to heaters, lamps or other electrical equipment.
- Do not store cylinders in your home as they are a serious hazard during a fire.
 If you have a medical need for cylinders, they should be kept upright and outdoors where possible – never store cylinders in basements, under stairs or in cupboards with electric meters/equipment.
- If you smoke, use a proper ashtray that won't burn and put it on a flat, stable surface so that it can't tip over easily. Don't leave your lit cigarettes unattended.
- Put candles/tea lights in heat resistant holders that hold the candle/tea light firmly and ensure it is placed on a flat, stable, heat resistant surface. Keep candles/tea lights away from anything that can catch fire, and never leave them unattended.
- Make sure you have a working smoke alarm and test it as part of your regular clearance sessions. You can contact your local fire and rescue service for advice.

- Plan and practise how to escape from your home if there were a fire. Choose an escape route and keep it clear of possessions – in the event of a fire this will help you to escape quickly or allow firefighters to reach you if you are unable to escape.
- Ensure possessions are stored on stable surfaces and do not stack items to a height that they become unstable – they could fall over blocking your escape.
- Newspapers and mail stored in bulk are highly combustible and will cause a fire to spread rapidly. Sort mail and newspapers on the day you receive them and recycle them on a regular basis.
- In the event of a fire, do not attempt to put it out yourself – leave your home straight away and call the fire brigade once you are safely outside. Do not stop on your way out to collect possessions and do not go back inside once you have escaped.
